HOTEL

PARKING

For those of you who will be driving in from the Tulsa metro area and not staying at one of the hotels, the Civic Center parkade is conveniently located north of the Cox Business Center on 3rd Street, between Houston and Denver, and is connected to the Convention Center through a covered walkway. Parking is currently \$10 per car, per day, per in and out. The parkade is owned and operated by American Parking and has 1,395 spaces. There are 10,000 parking spots within a short 10-minute walk!

ADVANCE REGISTRATION
